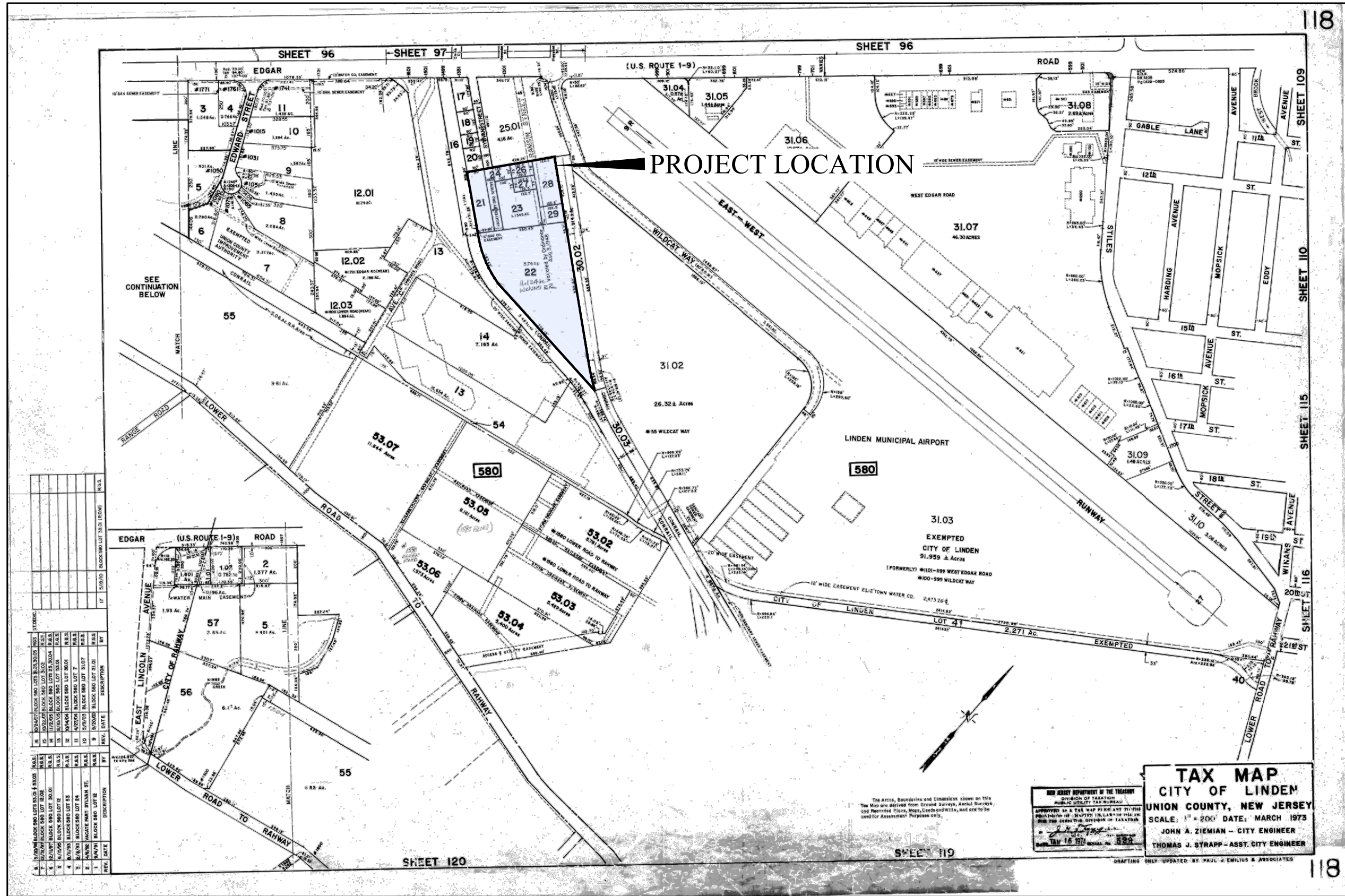

- A public hearing concerning the proposed Facility expansion was held on 4/15/2024, at 6pm at the Linden Free Public Library, 31 East Henry Street, Linden, NJ 07036. A technical difficulty relative to the virtual public hearing element was experienced & attendees attempting to log into the public hearing were only able to join by phone. As such a virtual public hearing will be held on 5/27/2024 at 6pm, which can be attended by logging onto <https://cleanharbors.webex.com> then: Click-on the grey box under “Join a Meeting” & enter the Access Code: 2431 053 0733; Enter your name & e-mail address; Click-on Join Meeting (you may have to click Join Meeting a second time); if requested enter Password: jNPJYnwB422. Please log into the virtual public hearing at least 10 minutes before the starting time. To get audio for the WebEx meeting if not available online (or if you want to attend by audio only) you will need to dial in at: 1 (415) 655-0003, Access Code: 24310530733## (participant ID is not required) & announce yourself once connected.
- The Facility is an existing operation permitted under the Resource Conservation & Recovery Act (RCRA), Clean Act (CA) & Clean Water Act amongst other governing laws & regulations. The Facility presently conducts hazardous & non-hazardous waste storage in containers & tanks in support of industrial recycling processes as well as waste treatment & storage prior to shipment offsite to authorized locations for final disposition. The facility plans to expand its hazardous & non-hazardous waste treatment processes by constructing a purpose-built enclosed building for waste treatment via stabilization & solidification processes in two (2) in-ground steel-lined concrete structures at a maximum capacity of 200 tons/day of hazardous wastes & 99 tons/day of non-hazardous wastes. Also, to support operations the Facility plans to add 3 new hazardous waste container storage areas for a capacity increase of 168,000 gallons & 1 other container storage areas for an additional capacity increase of 600 cubic yards. A Resource Conservation & Recovery Act (RCRA) permit modification & new Clean Air Act (CA) permit applications have been submitted to the NJ Department of Environmental Protection (NJDEP) for this facility expansion.

- The Facility has prepared an Environmental Justice Impact Statement (EJIS) that covers information required by NJAC 7:1C-3.2 to include executive summary; description of the municipal & neighborhood setting of the facility; description of the facility’s current & proposed operations; list of all the Federal, State, & local permits that are required; evidence of satisfaction of any local environmental justice or cumulative impact analysis ordinances; initial screening information obtained pursuant to N.J.A.C. 7:1C-2.3; assessment of the impacts both positive & negative of the facility on each environmental & public health stressor in the overburdened community; public participation plan; & demonstration including any necessary operational conditions & control measures that the facility will avoid a disproportionate impact that would occur by creating adverse cumulative stressors in the overburdened community. The EJIS has been submitted to NJDEP.
